


DECLARATION OF ACCEPTANCE OF OFFICE

(* Where the declaration is made before another person authorised by section 83(3) of the Local Government Act 1972, state instead the capacity in which that person takes the declaration (a).

(a) Under section 83(3) of the Local Government Act 1972, a declaration for members or elected mayors of a county, district or London borough council shall be made before two members of the council, its elected mayor, its proper officer, a justice of the peace or magistrate in the United Kingdom, the Channel Isles or the Isle of Man, or a commissioner appointed to administer oaths in the Supreme Court. A declaration for members of parish councils shall be made before a member or the proper officer of the council.

Notes:

1. A person elected to the office of Parish Councillor shall make the above Declaration before or at the first meeting of the Parish Council after his/her election.
2. The Declaration shall be made in the presence of a member of the Parish Council or the Clerk to the Parish Council and signed by that person at (a) or (b) above.
3. The completed Declaration must be handed to the Clerk of the Parish Council for his/her retention immediately after completion.
4. If an elected member of a Parish Council fails to comply with 1 and 2 above, their office shall become vacant.

Disclosable Pecuniary Interests (2012 Regulations)		
1. Employment, office, trade, profession or vocation	Carried out by you and/or by your spouse or civil partner for a profit or gain	
2. Sponsorship	Name(s) of any person or body other than the Council, who has made a payment or provision of any other financial benefit to you within the 12 month period preceding this notification in respect of any expenses incurred by you in carrying out your duties as a member or towards your election expenses.	
3. Contracts	Description of any contract under which goods and services are to be provided, or works executed, made between the Council and you and / or your spouse or civil partner or a firm, company or other body in which you and/or your spouse or civil partner has a beneficial interest and which has not been fully discharged	
4. Land	Address or other description of any land in the Council's area in which you and / or your spouse or civil partner has a beneficial interest. You only need to register land in the Council's area. This includes your home if you own it or rent it.	
5. Licences	Address or other description of any land in the Council's area for which you and / or your spouse or civil partner has a licence (alone or jointly with others) to occupy for a month or longer.	
6. Corporate tenancies	Address or other description of any land where the landlord is the Council and in which the tenant is a body in which you and/or your spouse or civil partner has a beneficial interest.	
7. Securities	Name(s) of any person or body who (to your knowledge) has a place of business or land in the Council's area and in whom you and/or your spouse or civil partner has a beneficial interest in a class of securities of that person or body that exceeds the nominal value of £25,000; or one hundredth of the total issued share capital (whichever is the lower) or if the share capital of that body is of more than one class, the total nominal value of the shares of any one class in which you, your spouse or civil partner has a beneficial interest that exceeds one hundredth of the total issued share capital of that class. "Securities" means shares, debentures, debenture stock, loan stock, bonds, units of a collective investment scheme within the meaning of the Financial Services and Markets Act 2000 and other securities of any description, other than money deposited with a building society. The nominal value of shares is the face value of those shares (the value recorded on the share certificate)

8. Gifts and hospitality	Names of any person or body, other than the Council from whom you have received any gift, benefit or hospitality with a value in excess of £100 which you have accepted as a member

9. Public Bodies	Bodies of which you are a member or hold a position of general control or management which exercise functions of a public nature	
10. Charitable bodies	Bodies of which you are a member or hold a position of general control or management which are directed to charitable purposes	
11. Bodies which influence public opinion or policy	Bodies of which you are a member or hold a position of general control or management whose principal purposes includes the influence of public opinion or policy (including any political party or trade union)
