Tenders may be submitted before this date and will be saved unopened in a secure digital folder, to be opened on the tender assessment date only. Please do not send hard copies to the parish council's mailing address.

#### Notes:

- Contract term is 3 years with right of termination with 30 days' notice if not satisfied with service.
- Pre-tender site visits may be arranged throughout Hanslope, as guided site visits with a member of Hanslope Parish Council. These must only be arranged via the clerk.
- All communication must be via the clerk on the above email address and attempts to contact members of the parish council regarding this contract will lead to disqualification.
- Contractors are expected to supply their Health and Safety Policies, Insurance Policy, evidence of professional certification/accreditation and Waste Disposal Certificate(s) with their tenders.
- Please also supply at least 3 contacts for references for comparable work.
- If suppliers are unlikely to be able to commence from 1<sup>st</sup> January 2023, they must make this clear

### **Specification**

### **Hanslope Village Litter Bins**

26 litter bins in total. 25 in the village and 1 at Tathall End

All 26 bins to be emptied every Friday

Additionally, 5 x bins emptied on a **Monday**, **Wednesday** and **Friday**: 3 on High Street and 2 in front of Hanslope Spar/Post Office and Hanslope News on Gold Street.

## **Hanslope Village Dog Waste Bins**

19 dog waste bins emptied once a week

#### 1. PURPOSE

- 1.1 This agreement is to undertake the waste collection and disposal from the dog waste bins and litter bins in and around Hanslope Parish, on a 3-year contract.
- 1.2 The services will consist of the emptying on a weekly basis, of the 19 dog waste bins and 26 Litter bins, currently installed at various locations throughout Hanslope, plus additional empties per week of the 5 Litter Bins, as stated.
- 1.3 It is expected that the emptying schedule as outlined will kept to and that this will be a year-round weekly service.

### 2. INSURANCE

2.1 CONTRACTORS will provide adequate Public Liability Insurances to a minimum of £10 million (ten million pounds)

### 3. FUNDING

- 3.1 CONTRACTORS will invoice the Council on a Monthly basis in arrears at the agreed rate per empty.
- 3.2 Should any dog waste or litter bin require repair or replacement, CONTRACTORS shall first provide the Council with a quotation for procurement and installation and will undertake these works with Council agreement.

### 4. LICENCES

- 4.1 CONTRACTORS shall maintain the appropriate Waste Transfer License, allowing it to collect waste on behalf of the Council.
- 4.2 CONTRACTORS shall be registered with the Environment Agency allowing it to carry waste on behalf of the Council.
